 - 2.(i) The restriction on the minimum number of residential units (as referred to in Special Condition No. (16)(b)(i)(xiii)(f) of the Land Grant) in Phase VI; 1,633
 - (ii) Special Condition No. (16) (k) of the Land Grant stipulates that except with the prior written consent of the Director of Lands ("the Director"), the Grantee shall not carry out or permit or suffer to be carried out any works in connection with any residential flat erected or to be erected on Site C1, Site G, Site H, Site I, Site J, Site N and Site O, including but not limited to demolition or alteration of any partition wall or any floor or roof slab or any partition structure, which shall result in such flat being internally linked to and accessible from any adjoining or adjacent residential flat erected or to be erected on Site C1, Site G, Site H, Site I, Site J, Site N and Site O. The decision of the Director as to what constitutes works resulting in a flat being internally linked to and accessible from any adjoining or adjacent residential flat shall be final and binding on the Grantee.
 - (iii) Clause 15 of the Third Schedule to the approved form of Sub-Deed of Mutual Covenant and Management Agreement stipulates that: "The Manager shall deposit in the management office of Phase VI the record provided by the Director of the information relating to the consent given under Special Condition No.16(k) of the Government Grant for inspection by all Owners of Phase VI free of costs and for taking copies of their own expense and on payment of a reasonable charge, all charges received to be credited to the Special Fund for Phase VI."
 - (iv) The total number of residential units provided in the Phase: 2,392

2.(i) 第(16)(b)(ix)(xi)(xii)條批地文件特別條款中對於第V期中住宅單位的最少數目的限制: 1,633
(ii) 第(16)(k)條批地文件特別條款規定，除非獲地政署署長（「署長」）事先書面同意，業主不得進行或准許或容許與其或將會建於地盤C1、地盤G、地盤H、地盤I、地盤J、地盤L及地盤O的任何住宅單位有關的任何工程（包括但不限於拆卸或更改任何分隔牆、任何地板或天花板或任何間隔牆），而使該單位可由內部連接及可由自己或其將會建於地盤C1、地盤G、地盤H、地盤I、地盤J、地盤N及地盤O的毗連或鄰近住宅單位進入，對於甚麼構成或可使一個單位可由內部連接及可由任何毗連的或鄰近住宅單位進入之工程，署長之決定應為最終並對業主有約束力。
(iii) 已批核的公共契約或管理協議第15條款規定：「經理人需要於第VI期管理處存放由署長提供、關於按第(16)(k)條批地文件特別條款發出的同意的資料紀錄，以供所有第VI期業主免費查閱，及在交付合理費用後，由自印或該等資料的副本，而該等費用將會存入第VI期之特別基金。」
